#### **Public speaking**

#### BCA application

- Location plan doesn't comply with planning legislation no scale & no adjoining properties shown. Car compound not shown as owned by BCA
- Application shows not visible from public road it is
- Pond not belonging to neighbour and they have disregarded crested newt etc that reside in there, even though mentioned in the BCA ecology report
- Already a lot of noise, auctions most days
- Residents don't want them to stop their business, just to be considerate to local residents
- Not sustainable in terms of employment
- 2 other depots have been closed to allow expansion of this one
- Development is creeping up on Pawlett
- Lighting- 40 lux (office standard is 50 lux). Unacceptable impact on neighbours
- Greenfield farmland (medium grazing quality) in current use will be taken out of use for this development. Surfacing land with tarmac reduces the ability of land to absorb water. Flood risk doc with application is incorrect-doesn't report all past flooding events. Rhyne is no longer maintained so unlikely to be able to cope with the run-off
- Destroys not improves biodiversity
- Increase in noise and pollution from engines/exhaust fumes
- Light pollution will be immense
- History of similar applications on site previously

#### 6. Roads and Footpaths:

#### a) Access road running alongside the Green

WB and JK have identified two other companies to contact and will approach them for quotes

#### b) Consider part funding request for parish strimmer volunteer

The PC had received a request from SCC (Rights of Way) to contribute half the cost of training a parish volunteer for the Somerset Strimmer Project. The Somerset Strimmer Project own and lend out machines, some of which are shared between parishes. Volunteers are trained in strimmer use and maintenance in a partnership between the County and Parish / Town Council. They are covered by the Council's public liability and personal accident insurance through signing a simple registration form.

A volunteer has expressed an interest in receiving training to take on strimming on rights of way within Pawlett and with their local knowledge they have already identified a number of paths that require seasonal vegetation clearance. The cost of this training to the PC would be approx. £65 + VAT

Councillors resolved to support the request to fund half the training costs

#### c) Consider signage to school

The school have approached WB with concerns that the primary school is inadequately signed in the village.

Councillors resolved that the clerk to write to school offering PC support for their request To Highways for better directional signage.

It was also noted that the sign to the Post Office on the A38, adjacent to the Green, needs removing as the PO has now closed. The clerk was requested to contact Highways.

#### i) Application 41/19/00008

20 Pound Road, Pawlett, Bridgwater, Somerset, TA6 4RZ Approval of reserved matters, for the erection of 3 dwellings, parking and alterations to access (existing dwelling to be demolished).

Since PPC submitted its response to SDC opposing this application due to the returned proposition of tandem parking, the applicant revised their application to allow for individual parking. PPC has therefore agreed with SDC to withdraw its objection to this application

#### b) Consider Planning Application 41/19/00007

British Car Auctions, Bristol Road, Walpole, Bridgwater, Somerset, TA6 4TN Change of use of land from agricultural to provide additional vehicle parking and storage, erection of fencing and 21 No. lighting columns. Erection of single storey extension to valet building for vehicle imaging.

The points raised in public speaking were echoed by councillors

- No business case provided for the additional parking
- No additional jobs will be created
- Does not reflect scale or character of the area
- Does not take into advice of environmental report
- Loss of habitat and valuable marshland grazing
- Increased water run off- exceeding recommended rates- will need buffering systemsno details shown in application
- Fails to consider contamination of flooded carpark-no protective bunding shown Councillors UNANIMOUSLY RESOLVED to object to this application for the many reasons already stated. Clerk (in consultation with AW in regard to wording) to respond to SDC.
